6. PUBLIC HEARINGS

- A. Public Hearing and Vote on a Petition from Eversource for a Grant for Location in Arsenal Street Northerly from UP# 5/46, approximately 50 feet west of Louise Street to install and maintain approximately 4 linear feet of conduit in the street. This work is necessary to provide electric service to 101 Walnut Street. The recommendations and conditions set out by the Department of Public Works shall be required upon approval of this application.
- B. Public Hearing and Vote on a Petition from Eversource for a Grant for Location in Bond

- Street Westerly from UP# 5/15, at the intersection of Bond Street and Arsenal Street to install and maintain approximately 11 linear feet of conduit. This work is necessary to provide service to a new traffic control cabinet. The recommendations and conditions set out by the Department of Public Works shall be required upon approval of this application.
- C. Public Hearing and Vote on a Proposed Loan Order for Arsenal park Improvements Phase B that the sum of \$10,359,500.00 is appropriated to pay costs of renovating Arsenal Park, including demolition and removal of the existing park features, installation of the new playground, splash pad, skate park, and tennis/pickleball/basketball courts, and construction, construction administration services, and construction contingency costs, including the payment of all costs incidental and related thereto; and that to meet this appropriation, the Treasurer, with the approval of the City Manager, is authorized to borrow said amount under and pursuant to M.G.L. c.44, §7(1), or pursuant to any other enabling authority, and to issue bonds or notes of the City therefor.
